AUTHORIZING CHANGE ORDER #1 FOR B&H CONTRACTING FOR THE CHLORINE PIPING FOR THE SALEM AVENUE WATER PLANT

WHEREAS a contract was previously awarded to B&H Contracting, Inc. for the

furnishing and installation of chlorine piping to the Salem Avenue water plant; and

WHEREAS the original contract for said work was in an amount of \$142,000.00; and

WHEREAS the governing body wishes to authorize Change Order No. 1, which will

result in an increase of \$26,400.00 in the contract price as per the attached form; and
