#### **ORDINANCE NO. 2017-06**

AN ORDINANCE AMENDING CHAPTER 2 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF HARVEY CEDARS, 1975, ENTITLED "ADMINISTRATION" AS IT PERTAINS TO OFF-DUTY POLICE FEES

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE BOROUGH OF HARVEY CEDARS, as follows:

<u>Section 1.</u> Subsection **2-5.2(J)** entitled "Employment of Off-Duty Police Officers",

paragraph 3, is hereby amended to read as follows:

3. All persons or entities shall pay to the chief financial officer of the

Borough of Harvey Cedars such hourly sum of eighty (\$80.00) dollars an

hour for such service. The borough shall remit to the member of the police

department performing such duties sixty-five (\$65.00) dollars an hour and

the remaining fifteen (\$15.00) dollars shall be retained by the borough for

administrative expenses and vehicle expenses.

<u>Section 2.</u> If any provision, section, subsection, or paragraph of this ordinance shall be

declared to be unconstitutional, invalid or inoperative, in whole or in part,

by a Court of competent jurisdiction, such provision, section, subsection, or

paragraph shall, to the extent that it is not unconstitutional, invalid or

inoperative, remain in full force and effect, and no such determination shall

be deemed to invalidate the remaining provisions, subsections, or

paragraphs of this ordinance.

Section 3. This Ordinance shall take effect upon final adoption after publication in

accordance with law.
