HARVEY CEDARS, NJ

The regular meeting of the Board of Commissioners of the Borough of Harvey Cedars, NJ was called to order by Mayor Oldham at 4:30pm. Commissioners Gerkens and Garofalo were present.

The Mayor asked all to rise for the Pledge of Allegiance.

Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. The schedule of this meeting of the Board of Commissioners of the Borough of Harvey Cedars is listed in the notice of meetings posted on the bulletin board located in the Borough Hall and the Borough's website and was published on December 14, 2017 in the Beach Haven Times and the Asbury Park Press.

Motion to approve the minutes of the previous meeting, April 17, 2018, was made by Commissioner Gerkens, seconded by Commissioner Garofalo.

The following residents and interested persons were in attendance to discuss the status of the wetlands property known as Block 1 Lot 1 and to offer any help to the Borough for obtaining the property: Susan Carril, James Street, Wendy & Peter McBrair, William Street, Howard & Myrna Asher, James Street, Vincent Vitale, Surf City, Fred Ballet, North Beach, Lisa Bromwell from Alliance for Living Ocean, Brita Wenzel from Save Barnegat Bay.

The Mayor stated he has met with Mr. George DiDonato twice and made an offer of what the Borough feels is a reasonable price (for this property); Mr. DiDonato feels the property must be worth something with all the interest in purchasing it and requested a higher price, but did not give an exact amount. The Board members discussed the following with the group: Green Acres funds are available as a matching grant and could be used to pay for the property at its appraised value, but the State requires a certified Green Acres appraiser; the Borough obtained appraisal was about \$25,500; Open Space Tax funds are available only for willing sellers, the Open Space Committee would need to be consulted; eminent domain is a long process; although designated as wetlands, there is no guarantee the property will not become developable; land swaps have been done in the past; public access to tidal flows should be researched to gain knowledge of how to legally access the water; any history of other similar issues would be helpful; the small pathway to access the bay is unsafe and the rubble should be removed; sit and wait is not a good option.

In conclusion, the Board will invite the Borough Attorney to attend the June 1st meeting with eminent domain information, and the representatives from Alliance for Living Ocean and Save Barnegat Bay will consult their organization's attorney regarding the same.

At 5:10pm the discussion concluded and the group left the room while the regular meeting continued.

PRIVILEGE OF THE FLOOR -

Mike Songer, asked about the proposed new water well being built at the Borough Hall, its cost and where to view the file. The Mayor explained the Borough has been fighting this for about 10 years; the Borough is over its permitted water allocation and in order to get a new permit the State is mandating a monitor well to test for salt water intrusion. Other points regarding the well were discussed: the cost is about \$700k to \$1million, with a grant for ½ the cost and an NJEIT 2% loan, which will be bonded; Long Beach Township will be responsible for part of the cost; the 77th Street well is from the 1960's, if it goes bad, the new well will take over; the State would be satisfied if we only built a monitoring well and never used it (after the test); the new well must be within a certain distance from an existing well, therefore the 80th Street location cannot be used; it will be no noisier than the well at 77th Street and water pressure will not be effected.

Mr. Songer asked if the Borough will be placing more beach mats on the walkovers. The Mayor stated that if the beach project builds the walkovers with hardpack, it may not be necessary to place the mats out this year.

ORDINANCE NO. 2018-06

AN ORDINANCE OF THE BOROUGH OF HARVEY CEDARS, OCEAN COUNTY, NEW JERSEY AMENDING CHAPTER 19 ENTITLED "STREETS & SIDEWALKS" AS IT PERTAINS TO THE COMMERCIAL USE OF PUBLIC STREET ENDS

THE BOARD OF COMMISSIONERS OF THE BOROUGH OF HARVEY CEDARS DOES ORDAIN AS FOLLOWS:

Section 1. Chapter 19 of the Borough Code of the Borough of Harvey Cedars entitled "Streets and Sidewalks" is hereby amended and supplemented so as to add a new Section 19-2 entitled "Commercial Use of Public Street Ends", which shall read as follows:

19-2 COMMERCIAL USE OF PUBLIC STREET ENDS.

- **19-2.1 Definition.** As used in this section "street end" shall mean the end of any road, highway, public way, public alley, easement or other right of way that is directly adjacent to bay waters.
- **19-2.2 Permitted Use.** From October 15th through May 14th commercial businesses shall be permitted to use any public street end for loading and unloading materials under the following conditions:
- 1. Loading and unloading shall be between 9:00AM to 5:00PM
- 2. No loading or unloading on weekends and holidays
- 3. Idling of vehicles and equipment are prohibited
- 4. Mooring to public property is prohibited
- 5. No overnight dockage
- **19-2.3 Prohibited Use**. From May 15th through October 14th commercial businesses are prohibited from using any public street end for loading and unloading purposes.
- **19-2.4 Exceptions**. In emergency situations, the Chief of Police or his designee may grant approval to use a street end during prohibited times. In the case of any other non-emergency, the matter shall be referred to the Governing Body who may allow temporary use for any civic purpose with concurrence of the police department concerning any possible safety issues. Allowed road openings shall be exempt from this provision.
- **19-2.5 Violations.** Any person, corporation or business entity that violates or fails to comply with this section or any of the rules and regulations promulgated hereunder shall, upon conviction thereof, be punishable by a minimum fine of five hundred dollars (\$500.00) for the first offense. Each day for which a violation of this section occurs after the first offense shall be considered a separate offense. Any subsequent offense conviction shall be punishable by a minimum fine of one thousand dollars (\$1,000.00).
- <u>Section 2</u>. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
- Section 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.
- Section 4. This ordinance shall take effect upon its passage and publication as required by law and upon the approval of the County of Ocean as it applies to any effected Ocean County street end in the Borough.

ORDINANCE NO. 2018-07

AN ORDINANCE OF THE BOROUGH OF HARVEY CEDARS, OCEAN COUNTY, NEW JERSEY AMENDING CHAPTER 13 ENTITLED "ZONING" AS IT PERTAINS TO OFF-STREET PARKING REQUIREMENTS IN THE GENERAL BUSINESS DISTRICT

THE BOARD OF COMMISSIONERS OF THE BOROUGH OF HARVEY CEDARS DOES ORDAIN AS FOLLOWS:

- Section 13-11.5b5 of the Code of the Borough of Harvey Cedars is amended to read:
 - 5. Restaurants, Full Service
 - One (1) off-street parking space for each three (3) seats
 - Bench restaurant seats shall be counted as one seat for each 30 inches of length
 - Waiting benches are permitted
- Section 2. Section 13-11c of the Code of the Borough of Harvey Cedars is hereby deleted and in its place and stead the following shall be inserted:
 - c. Violations and Penalties.
 - i. Sections 13-11.5b subsections 5 through 8 are the result of the Borough attempting to allow restaurants to create additional seating by taking advantage of off-street parking for employees and by allowing additional off-street parking off-site under certain conditions. The Borough has assumed additional enforcement duties that are time consuming, labor intensive and are mainly effective on weekends and holidays. For these reasons the Borough requests the consideration of minimum fines.
 - ii. Any person, corporation or business entity operating a restaurant as provided in Section 13-11.5(b)5 through 8 that violates or fails to comply with these sections or any of the rules and regulations promulgated hereunder shall, upon conviction thereof, be punishable by a minimum fine of five hundred dollars (\$500.00) for the first offense. Each day for which a violation of this section occurs after the first offense shall be considered a separate offense. Any subsequent offense conviction shall be punishable by a minimum fine of \$750.00 for 1-5 seats over the permitted limit, \$1000.00 for 6-10 seats over the permitted limit, and \$1,250.00 for 11 or more seats over the permitted limit.
 - iii. Any other violations of Chapter 13 shall be dealt with pursuant to Section 13-19 of this Chapter.
- <u>Section 3</u>. This Ordinance repeals any inconsistent ordinance or ordinances or part or parts thereof.
- Section 4. That if any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The Borough Mayor and Commissioners hereby declare that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.
- <u>Section 5</u>. This Ordinance shall take effect upon final adoption after publication in accordance with law.
