

The regular meeting of the Board of Commissioners of the Borough of Harvey Cedars, NJ was called to order by Mayor Oldham at 4:37pm. Commissioners Imperiale and Rice were present.

The Mayor explained his displeasure of how the elevations have been updated and how they affect flood insurance rates.

Mr. Fritz asked if the requirements include the raising of the property. The Mayor said that is a Borough requirement, not Federal, and the other Island towns are following suit.

PRIVILEGE OF THE FLOOR –

Commissioner Imperiale stated the “No Shave November” campaign raised about \$25,000; the Police Department is now administering a toy drive for foster children.

Mayor Oldham stated Verizon finally repaired the concrete hole around the new telephone pole at 79<sup>th</sup> Street that was replaced about 4 years ago. He said there may be money in the Infrastructure Bill for the Army Corps to renourish the beach in 2022 or 2023. He said he is still pushing for the manholes to be repaired, and was told it should be done by the end of the year. The Mayor said 72<sup>nd</sup> and 85<sup>th</sup> Street are being worked on, and Public Works is moving along with the watermain on Holly Ave.; once the watermain is done, it will be repaved in the Spring; drainage on Essex is going to be repaired; a new fire hydrant will be added to Holly Ave. The Mayor stated he is working on a design near the new flag pole in the park, a plan is being put together for selling bricks.

Mr. Fritz asked how the beach nourishment experiment worked this summer. The Mayor said he has not received a definitive answer from the State or Feds if the pilot project has worked, but some residents have told him they see a difference. The Mayor explained the sand was dumped (in the ocean close to shoreline) near the center of town and should move north.

OPERATION AND MAINTENANCE OF A  
SERVER-BASED MOBILE DATA TERMINAL SYSTEM**

**WHEREAS** the Uniform Shared Services and Consolidation Act, NJSA 40A:65-1 et. seq., authorizes municipalities to agree to provide shared services when approved by resolution under NJSA 40A:65-5; and

**WHEREAS** the Long Beach Township Police Department operates and maintains a server-based Mobile Data Terminal system to link mobile computers to agency systems in order to increase the sworn officers' ability to perform, report and record checks in the field; and

**WHEREAS** it is the desire of the governing body to authorize the execution of a Shared Services Agreement with the Township of Long Beach as the lead agency for the operation and maintenance of a server-based Mobile Data Terminal system.

**NOW, THEREFORE, BE IT RESOLVED** by the governing body of the Borough of Harvey Cedars, County of Ocean, State of New Jersey as follows:

1. The Commissioner of Public Safety and the Municipal Clerk are hereby authorized to execute a Shared Services Agreement with the Township of Long Beach as lead agency for the operation and maintenance of a server-based Mobile Data Terminal (MDT) system in accordance with the provisions of law effective January 1, 2022 through December 31, 2024 at the following rates per MDT or other device connected to the MDT System:
  - a. \$115.00 for 2022
  - b. \$115.00 for 2023
  - c. \$115.00 for 2024
2. That a copy of the Agreement referenced herein shall be kept on file and made available for public inspection at the Municipal Clerk's Office during normal business hours.
3. That a certified copy of this resolution shall be forwarded to the Chief of Police and the Chief Financial Officer for the Borough of Harvey Cedars and to the Township of Long Beach.

**WHEREAS** the Driving While Intoxicated Enforcement Program (DWIEP) is a traffic safety program run by the Ocean County Prosecutor’s Office for the purpose of identifying and removing intoxicated drivers from the roadways; and

**WHEREAS** these programs receive funding from the State of New Jersey and the County of Ocean; and

**WHEREAS** it is the desire of the Board of Commissioners of the Borough of Harvey Cedars to enter into an agreement with the County of Ocean for the purpose of setting forth the terms and conditions regarding the assignment of police officers employed by the Borough of Harvey Cedars to the DWIEP.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Borough of Harvey Cedars, County of Ocean, State of New Jersey that the Mayor and Municipal Clerk are hereby authorized to execute a Shared Services Agreement with Ocean County for the Driving While Intoxicated Enforcement Program a copy of which is on file in the Municipal Clerk’s office, effective October 1, 2021 through September 30, 2022.

**WHEREAS** NJSA 40A:65-1 et. seq., authorizes several municipalities to agree to provide code enforcement services jointly by contract when approved by resolution under NJSA 40A:65-5; and

**WHEREAS** it is the desire of the Borough of Harvey Cedars to contract with the municipalities of Beach Haven, Surf City and Barnegat Light to jointly employ a Construction Code Officer and Building Inspector.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Commissioners of the Borough of Harvey Cedars, County of Ocean, State of New Jersey, as follows:

1. The Mayor and Clerk are hereby authorized and directed to enter into and execute a Shared Services Agreement with the municipalities of Beach Haven, Surf City and Barnegat Light for the provision of Uniform Construction Code enforcement and administration services.
2. A copy of this agreement shall be kept on file and be available for public inspection in the office of the Borough Clerk.
3. This agreement shall be effective as of January 1, 2022 and shall take effect upon full execution by the parties and shall remain in full force and effect for a period of one (1) year expiring on December 31, 2022.
4. A certified copy of this resolution shall be forwarded to the Borough of Beach Haven, Borough of Surf City, Borough of Barnegat Light and the Construction Code Official.
