- Original work only no merchants, dealers, or agents.
- Paintings, mixed media, photography, and fine crafts. NO REPRODUCTIONS, although prints of the artist's original work are acceptable.
- Each work must be labeled with the price.
- Approximately 10 x 10 ft. spaces will be given to each entry. Bring your own modules. Vehicle accessible spaces are *extremely limited*. Cars must be moved to designated parking prior to show start. You must bring everything you need to set up your display.
- Bring covers and be prepared for summer squalls. This is an outdoor show and no rain date is provided.
- Tent spikes are *prohibited*. Please utilize weights to tie-down your tent.
- A limited number of double spaces will be available if reserved in advance.
- Please submit pictures of your work, including one of your display (no cd's or slides) for review along with your check. In most cases, when mailed by JUNE 1st deadline an email notification of your acceptance will be sent out by JUNE 25th. If decision is pending you will be notified that your application is being considered. If accepted, pictures will be returned the day of the show.
