The Mayor read a facility request from the Harvey Cedars Taxpayers Association that was submitted to the Clerk's Office just prior to the meeting. The park was requested for the annual Taxpayers Social.

A motion was made by Commissioner Rice, seconded by Commissioner Gieger to approve the use of the Pavilion in Sunset Park to the Harvey Cedars Taxpayers Association for their annual Spring Social on Saturday, June 15, 2024 from 3:00pm-6:00pm. Approximately 40 are people expected.

COMMISSIONER REPORTS/ TOPICS OF INTEREST -

Commissioner Rice thanked everyone for paying their taxes.

Commissioner Gieger thanked Jay Madden for donating architectural designs to the borough for a shade pergola which will be built by the pickleball courts to provide shade for players. Gieger also mentioned that the borough is applying for grants to pay for the construction of the "shade hut", Gieger hopes that we will get some grant money to offset the costs of the improvement.

Gieger stated that an additional pickleball court will be constructed where the basketball court currently is. Gieger listed off planned improvements for the park and told the audience that suggestions for the park are welcome. Some of the current planned improvements include; bathroom renovations, a new landscape design, and perhaps even a butterfly garden.

Gieger stated that funds are now available to start work on flooding issues. New bulkheads will be installed on 78th Street and Essex Ave. to eliminate flooding on those streets. Bay Terrace will also be surveyed for elevations by Van Cleef Engineering Firm so they can make recommendations as to how to elevate flooding issues in prone areas of Harvey Cedars.

Mayor Imperiale mentioned that the Sidewalk Survey resulted in approximately 75% of the respondents being in favor. Commissioner Rice stated that he feels that the survey was not valid. Rice stated that the survey was emailed to non-residents, and that it was not clear enough to get a true sense of what the residents of Harvey Cedars want.

Mayor Imperiale announced that there will be a little socialization after the two presentations. Imperiale invited attendees to "socialize a little" post meeting. The mayor again thanked everyone for coming out to this special event.

POLICE DEPARTMENT AWARD PRESENTATION -

Chief Burnaford acknowledged special guest Harry Delgato from the NJ Chiefs of Police Accreditation Program.

Mr. Harry Delgado acknowledged the Harvey Cedars Police Department for going through their fifth reaccreditation process. Delgado stated that only approximately 3.7% of all New Jersey police departments can say that they have been accredited 4 years in a row, making Harvey Cedars Police Department among the very few. Mr. Delgado read aloud a statement of recognition for the Police Department for their professional achievement which qualify the department for a 4th cycle reaccreditation.

Chief Burnaford thanked Mr. Delgado for his presentation. Burnaford stated that he was very proud of the officers in his department. Burnaford said that they are special because of their commitment to the community, and their high standard of professionalism and accountability. Burnaford explained that police officers are held to an extremely high standard and professionalism, and the Harvey Cedars Police Department exemplifies all of those qualities.

Burnaford gave a brief background of the annual awards, and presented the following awards:

Ocean County Pistol Match Awards:

For marksmanship abilities, Sargent Steve Frazee was recognized for taking second place in the expert category. Also recognized were Sergeant Steve Frazee and Detective Nick D'Andrea for taking 3rd place in the two-person team category.

<u>Certificate of Merit:</u> Chief Burnaford recognized Confidential Administrative Assistant, Daniele Tilton for her work on accreditation. Burnaford credited Tilton with taking on the time-consuming responsibility and mastering it in a short time. Chief Burnaford credited a successful recertification to Tilton, stating that it would not have happened without her efforts.

Officer of the Year – Presented to Officer Ben Mrozinski, who Chief Burnaford describes as an all-around outstanding officer who represents the Harvey Cedars Department extremely well, both on duty and off duty. Chief Burnaford stated the following attributes about Officer Mrozinski; his positive attitude, the ability to get along with everyone, his extreme empathy towards the public.

Chief Burnaford thanked the Governing Body for their continued support to the Harvey Cedars Police Department.

The Board congratulated and thanked all award recipients. Mayor Imperiale stated that he couldn't be prouder of the organization and is proud to be the Commissioner of the Police Department.

MARIS STELLA PRESENTATION -

Mayor Imperiale thanked Open Space Committee member, Mr. Ed O'Connor for all of his help and support and for making this special meeting with Maris Stella possible. Imperiale introduced the guests from Maris Stella who were in attendance. Introductions were made for Sister Mary Shaughnessy/General Superior, Sister Pat Dotzauer/Administrator, Sister Ceil MacManus/Assistant General Superior, Sister Maryann Campeotto/Council Member, Sister Ellen Farrell/Council Member, Sister Joan Repka and Sister Mary Morley by Mayor Imperiale, followed by the reading of the resolution honoring the sisters, which is attached hereto.

The Sisters received a huge applause from those in audience. A signed resolution was given to the group.

PRIVILEGE OF THE FLOOR -

Sue Ellen Riffkin, 77th Street resident stated that she was concerned about flooding at the bay beach. Rifkin suggested narrowing the beach area for beach goers for both swimmer safety and that it would allow for more space for launching small boats near the Yacht Club. Mayor Imperiale stated that he will be meeting with Commissioner Gieger to address the issue.

Fred Schragger, Salem Ave. resident asked about bike lane designation and widths on Long Beach Blvd. in the business district. Commissioner Gieger stated that the road will be restriped within the next few weeks and the lines should be restriped at that time.

Hillary Fiorella, 80th Street resident asked if June 15th was still a possible wrap-up date for the Streetscape Project. Commissioner Gieger listed items that needed to be done prior to wrap-up and indicated that the date still looks reasonable.

John Defrisco, Holly Ave. resident asked if improvements were planned for the bocce court in Sunset Park. Commissioner Gieger stated that yes, improvements can be made.

Todd Rendfrey, James Street resident asked if there was any news on, and advise for residents regarding the high number of dead birds in Harvey Cedars. Mr. Rendfrey asked if residents should bag the dead birds and dispose of them. Commissioner Gieger stated that they will look into the matter and post something in the next currents issue for the residents.

- Section 1. Section 4-8 of the Code of the Borough of Harvey Cedars, entitled "Fees", is hereby amended at subsection 4-8.1 (Fees Established) to repeal and replace subsection g. with the following:
 - g. Record copy fees and special service charges.
 - 1. The fees for the duplication of government records requests are set by N.J.S.A. 47:1A-5 and at present are set at \$0.05 per letter size page or smaller, and \$0.07 per legal size page or larger. Those fees shall be revised by operation of law in the event the N.J.S.A. 47:1A-5 is amended.
 - 2. If the actual cost of duplication of government records exceeds the rates set by N.J.S.A. 47:1A-5, the Borough may charge the actual cost of duplicating the record. The actual cost of duplicating the record upon which all copy fees are based shall be the cost of the materials and supplies used to make a copy of the record but shall not include the cost of labor or other overhead expenses associated with making a copy except as provided for in Subsection 3 below. Access to electronic records and non-printed materials shall be provided free of charge, but the Borough may charge for the actual cost of any needed supplies required by the request.
 - 3. Whenever the nature, format, manner of collation, or volume of a government record embodied in the form to be located, inspected, reviewed and analyzed, redacted, and/or copied is such that the record cannot be reproduced by ordinary document copying equipment in ordinary business size and/or where the location, inspection, review and analysis, and/or redaction involves an extraordinary expenditure of time and effort to accommodate the request, in addition the actual cost of duplicating the record, if any, a special service charge shall be assessed and charged in accordance with N.J.S.A. 47:1A-5 and the rate set forth herein. A special service charge shall be imposed for the cost of supervision if a requestor desires to examine documents that the requestor is not permitted to examine alone in order to ensure the records are not tampered with and to ensure that confidential and privileged documents remain secure.
 - (a) Where the required work can be performed by an officer and/or employee of the Municipal Clerk's office, the special service charge shall be equal to the prorated salary of the lowest salaried employee in the Municipal Clerk's office for the time expended to comply with the request.
 - (b) Where the work must be performed by a member of the Police Department due to authorized access requirements and/or the nature of the records requested, the special service charge shall be equal to the prorated salary of the lowest ranked full-time police officer employed by the Police Department trained to perform the required task for the time expended to comply with the request.
 - (c) Where the required work necessitates a third party to perform the work, the special charges shall be equal to the fees and costs charged by the third party in accordance with the Local Public Contracts Law.
 - (d) The requestor shall have the opportunity to review and object to the special service charges prior to it being incurred. If the requestor wishes to proceed with the production of the records, the requestor shall provide 50% of the estimate for the special service fee prior to commencement of the work and shall pay the remainder of the special service charge once the work is completed and as a condition of receipt of the

documents requested. No documents shall be produces without full payment of the special service charge.

<u>Section 2</u>. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

Section 3. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

AN ORDINANCE OF THE BOROUGH OF HARVEY CEDARS, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING CHAPTER 13 ENTITLED "ZONING" AND CREATING A NEW CHAPTER 25 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF HARVEY CEDARS, 1975, TO BE ENTITLED "OUTDOOR LIGHTING"

WHEREAS, Borough of Harvey Cedars deems it appropriate, necessary, and proper for the good government, order, the protection of persons and property, and for the preservation of the public health, welfare, and safety of Borough and its inhabitants to adopt certain regulations pertaining to the regulation of certain outdoor lighting in the Borough; and

WHEREAS, Lighting Ordinances currently exist within the Borough's Zoning Regulations Chapter; and

WHEREAS, the Board of Commissioners wish to create a dedicated lighting chapter of the Revised General Ordinances of Harvey Cedars; and

WHEREAS, other municipalities in the State of New Jersey and throughout the country have taken similar action on the grounds that outdoor lighting can constitute a nuisance and be inimical to the public health, welfare, and safety.

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Borough of Harvey Cedars, Ocean County, State of New Jersey, in accordance with the aforesaid recitals, which are incorporated herein by reference, that:

- Section 13-7.11 Entitled "Lighting" located in Chapter 13 of the Revised General Ordinances of the Borough of Harvey Cedars is hereby repealed in its entirety for the purpose of moving lighting regulations to a dedicated Outdoor Lighting Chapter.
- Section 2. The Revised General Ordinances of the Borough of Harvey Cedars is hereby amended to create a new Chapter 25 entitled "Outdoor Lighting" which shall read as follows:

CHAPTER 25 OUTDOOR LIGHTING

- **25-1 INTENT.** The intent of this Ordinance is to regulate outdoor lighting in a manner which encourages the conservation of energy, improves or maintains the nighttime visual environment, and prevents and/or eliminates misdirected or excessive artificial light, light trespass, and/or unnecessary sky glow.
- **25-2 DEFINITIONS.** The following words, phrases and terms as used in this chapter are hereby defined for the purpose thereof as follows.

ARTIFICIAL LIGHT SOURCE - A man-made thing or object from which light originates.

ENFORCEMENT OFFICER - The Borough Code Enforcement Officer or designee.

FOOTCANDLE - A unit of measurement of illuminance (1 footcandle equals 1 lumen per square foot of area, 450 lumens equal approximately a 40-watt bulb)

GLARE - Illuminance within the visual field of a human eye which is sufficiently greater than the intensity of illuminance to which the eye is adapted that it causes annoyance, discomfort, nuisance, and/or loss in visual performance and visibility.

ILLUMINATION - See Lighting.

ILLUMINANCE - The total amount (density) of visible light incident upon (i.e., illuminating) a point of a surface from all directions above the surface measured in footcandles (note: the "surface" may be a part, or all, of a physical object or an imaginary plane)

LIGHT FIXTURE - An electrically powered lighting device consisting of a lamp, a lamp holder, an electrical ballast (if necessary), and the means for connecting the device to an electrical power source.

LIGHT TRESPASS - Any form of illumination emanating from a light fixture or light source whether internally or externally illuminated on a property that penetrates another property and creates a nuisance, annoyance, or glare.

LIGHTING - The deliberate utilization of one or more artificial light sources to achieve an aesthetic or intended effect

LUMEN -Measurement of light output. One lumen is equal to the amount of light emitted by one candle that falls on one square foot of surface located one foot away from the candle.

OBJECTIONABLE DIRECT GLARE SOURCE - A glare resulting from artificial light sources and excessive levels of illumination or insufficiently shielded light sources emanating from light fixtures in the field of view here the lens, lamp, or reflector offensively visible above a height of 5 feet at a property line, public or private roadway. Rule of Thumb – if the lamp (bulb) is objectionably visible from outside the illuminated property's boundary, then it's a direct glare source. Rule of Thumb: If you must squint to see due to glare within your field of view, then it's objectionable.

OUTDOOR LIGHTING - The lighting of areas exterior to the walls of enclosed buildings and/or within structures having open or partially open walls such as canopies, porte cocheres, pavilions, gazebos, etc., artificial lights sources and/or light fixtures.

25-2 OUTDOOR LIGHTING RESTRICTIONS

- a. All outdoor lighting shall be of a soft or glare-free type and shall not cast an illumination color which shall be distractive, obliterate, or obscure the view, or be ultraviolet, strobic, pulsating, flashing, travel, or of any unnatural kind.
- b. No outdoor lighting or outdoor light fixtures shall shine directly upon any neighboring property or into any room or rooms of structures on any neighboring property in a manner that creates glare for the occupants of any neighboring property or in such a manner that the lighting constitutes an objectionable glare source of light trespass.
- c. No outdoor wall wash soffit fixtures or other wall illumination of the building shall be permitted.
- d. No outdoor lighting shall be located on any structure adjacent to a natural body of water if such outdoor lighting creates glare, constitutes a safety hazard, or otherwise constitutes an objectionable direct glare source.

25-3 OUTDOOR LIGHTING PLACEMENT REGULATIONS

- a. Path lighting shall be placed a minimum of 18 inches from the property lot lines and shall be directed downwards or shielded to diminish glare.
- b. Landscape lighting shall be directed towards the structure located on the lot upon which it is placed.
- c. Lighting adjacent to any right-of way shall be no less than 10 feet from any curb or edge of pavement.
- d. All path or landscape lighting placed on grade, docks, or top of bulkheads shall not exceed 18 inches in height.
- e. Any flag or flagpole that is illuminated shall be illuminated by a source or sources with a beam spread no greater than necessary to illuminate the flag.

25-4 COMMERCIAL OUTDOOR LIGHTING RESTRICTIONS

All commercial properties shall comply with the lighting restrictions set forth herein.

25-5 EXCEPTIONS

a. The outdoor lighting regulations shall not apply to the following.

- (1) Decorative holiday lighting from December 1st through the following January 15th, October 20th through November 2nd, and July 3rd through July 5th.
- (2) Temporary emergency lighting.
- (3) Outdoor lighting emitting less than 100 lumens.

25-6 ENFORCEMENT

All property owners and occupants shall control the placement and direction of all exterior lighting located within the property lot lines and ensure the lighting shall not create a nuisance, annoyance, or light trespass to adjacent properties or public right of ways. Failure to comply with the requirements set forth above shall be a violation of this Chapter. The provisions of this Chapter shall be enforced by the Enforcement Officer.

25-7 REMOVAL AND ABATEMENT

Whenever an outdoor light fixture and/or artificial light source is determined to be in violation of this Chapter, a notice of violation shall be given to the owner of the property to turn off the light immediately, and, thereafter, remove same within 30 days.

25-8 VIOLATIONS AND PENALTIES

Any person, corporation or business entity that violates or fails to comply with this section or any of the rules and regulations promulgated hereunder shall, upon conviction thereof, be punishable by a minimum fine of one hundred dollars (\$100.00) for the first offense. Each day for which a violation of this section occurs after the first offense shall be considered a separate offense. Any subsequent offense conviction shall be punishable by a maximum fine of one thousand dollars (\$1,000.00).

25-9 NOTICE OF VIOLATION

Except where otherwise set forth in the specific Chapter of the Borough Code, all notices of violation of the Borough Code elected to be issued by the designated official, at the official's discretion, shall be served by either certified mail or personal service. Unless otherwise required by law, a notice of violation shall not be a precondition to the issuance and service of a summons, a summons may issue and be served without a prior notice of violation, and the service of a summons shall be in accordance with the Rules Governing Practice in Municipal Courts. In the event the designated official elects to issue a notice of violation, he or she shall possess the discretion to determine the amount of time set forth in the notice to remedy the violation prior to the issuance of a summons or the Borough's institution of an appropriate legal action in a court of competent jurisdiction.

- Section 3. All ordinances, or parts of ordinances, inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.
- Section 4. If any word, phrase, clause, section, or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the ordinance and the remainder of the ordinance shall remain in full force and effect.
- Section 5. This ordinance shall take effect after final adoption and publication as required by law.

AN ORDINANCE OF THE BOROUGH OF HARVEY CEDARS, OCEAN COUNTY, NEW JERSEY AMENDING CHAPTER 13 ENTITLED "ZONING" AS IT PERTAINS TO PROHIBITED USES AND OFF-STREET PARKING REQUIREMENTS IN THE GENERAL BUSINESS DISTRICT

THE BOARD OF COMMISSIONERS OF THE BOROUGH OF HARVEY CEDARS DOES ORDAIN AS FOLLOWS:

- Section 13-11.4 entitled "Prohibited Uses and Buildings", paragraph b. is hereby amended to read as follows (underscores represent additions; strikethroughs represent deletions):
 - b. Any type of business using jukeboxes, record players with external speakers, <u>live music</u>, or other noise making devices designed to attract attention to the business being conducted within the premises. <u>Indoor or outdoor music with outdoor speakers, loudspeakers, music amplification or reproduction equipment after the hours of 7:30pm, Sunday through Thursday, and after the hours of 8:00pm on Fridays and Saturdays. Excessive amplification, drum use, or any performance including more than three (3) persons is strictly prohibited.</u>
- Section 2. Section 13-11.5 entitled "Off Street Parking Requirements", section 3 "Retail Food/Limited Service" is hereby amended and supplemented to read as follows (underscores represent additions; strikethroughs represent deletions):
 - (a) One (1) off-street parking space for each 200 square feet of retail store area.
 - (b) One (1) off-street parking space for each three four (4) seats. of limited service area.
 - (c) Bicycle spots shall count as one (1) parking spot for each four (4) bicycle slots; two (2) parking spaces maximum.
 - (d) <u>Courtesy benches permitted.</u>
- Section 3. Section 13-11.5 entitled "Off Street Parking Requirements", section 4 "Restaurants, Limited Service" is hereby amended to read as follows (underscores represent additions; strikethroughs represent deletions):
 - (a) One (1) off-street parking space for each three four (4) seats.
 - (b) Bicycle spots shall count as one (1) parking spot for each four (4) bicycle slots; two (2) parking spaces maximum.
 - (c) <u>Courtesy benches permitted.</u>
- Section 4. Section 13-11.5 entitled "Off Street Parking Requirements", section 5 "Restaurants, Full Service" is hereby amended to read as follows (underscores represent additions; strikethroughs represent deletions):
 - (a) One (1) off-street parking space for each three-four (4) seats.
 - (b) Bicycle spots shall count as one (1) parking spot for each four (4) bicycle slots; two (2) parking spaces maximum.
 - (c) Bench restaurant seats shall be counted as one (1) seat for each 30 inches of length.
 - (d) Waiting benches permitted.
- <u>Section 5</u>. This Ordinance repeals any inconsistent ordinance or ordinances or part or parts thereof.
- Section 6. That if any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The Borough Mayor and Commissioners hereby declare that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.
- <u>Section 7</u>. This Ordinance shall take effect upon final adoption after publication in accordance with law.

RS 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

RESOLUTION OF THE BOROUGH OF HARVEY CEDARS, COUNTY OF OCEAN, STATE OF NEW JERSEY ADOPTING A VISION ZERO POLICY

WHEREAS, the life, safety, and health of all persons living and traveling within the Borough of Harvey Cedars are our utmost priority, and no one should die or be seriously injured while traveling on our Borough roads; and

WHEREAS, Vision Zero is the concept that traffic deaths and serious injuries on our roadways are unacceptable; and

WHEREAS, Vision Zero is a holistic strategy aimed at eliminating all traffic fatalities and severe injuries suffered by all road users while increasing safe, healthy, equitable mobility for all; and

WHEREAS, Vision Zero supports a paradigm shift by designing streets and transportation systems to move all people safely, including people of all ages and abilities, pedestrians, bicyclists, public transit users, scooter riders, and motorcyclists, as well as drivers and passengers of motor vehicles; and

WHEREAS, Vision Zero recognizes that people will sometimes make mistakes, so the road system and related policies should be designed to ensure that those inevitable mistakes do not result in severe injuries or fatalities; therefore, the Borough Board of Commissioners are expected to improve the roadway environment, policies, and other related systems to lessen the severity of crashes; and

WHEREAS, Harvey Cedars, in spite of being just two-miles long, suffered a fatal traffic accident in the last year, and nearly four dozen other accidents, several with severe injuries, over the last four years; and

WHEREAS, the Borough of Harvey Cedars year-round population of approximately 500 residents grows to over 10,000 residents and visitors in the season from Memorial Day to Labor Day, greatly increasing the number of vehicles, pedestrians, and bicyclists on our roads; and

WHEREAS, the lack of shoulders, sidewalks, and bike lanes on Harvey Cedars streets are clear contributing factors to accidents and injuries; and

WHEREAS, the Borough of Harvey Cedars has taken steps to work with the New Jersey Department of Transportation and the New Jersey Department of Roads and Bridges to implement safety measures such as:

- 1) Enhanced enforcement of sight triangles to provide unobstructed vision of streets and sidewalks.
- 2) The Borough has applied for a reduced speed limit area through the commercial section of Harvey Cedars between 76th and 82nd Street on Long Beach Blvd.
- 3) The Borough has requested the installation of a pedestrian and traffic switch for the 80th street traffic light at the main intersection in Harvey Cedars.

4) Education and enforcement of New Jersey Safe Passage Law.

5) Utilize traffic calming techniques of car lane width from 11.5 feet to 10 feet

throughout the Borough; and

WHEREAS, making streets safer for all people using all modes of transportation

will encourage people to travel on foot, by bicycle, and by the public trolley which the

Borough of Harvey Cedars financially supports; and

WHEREAS, successful Vision Zero programs are a result of both a complete

government approach (i.e., interdepartmental, coordinated initiatives) and community

support of Vision Zero objectives and action plans; and

WHEREAS, Vision Zero resolutions have been adopted by many jurisdictions

across the United States; and

WHEREAS, the Borough of Harvey Cedars has already completed Phase 1 of a

Streetscape Project to provide sidewalks, shoulders, and a bike lane throughout the

commercial zone in the Borough, to be completed by the anticipated Phase 2 and Phase 3

of the Streetscape Project.
